Exhibit booth space is given once your registration form and your vendor fee has been received by Business Planning, and is based on space.

FIRST COME, FIRST SERVED!

The event will be held outside, "rain or shine". All tables and booths will be housed underneath professionally installed tents.

Each **PAID** booth will receive the following: 1- 6' table, 2 chairs, Vendor Badge and Continental breakfast. **Be prepared to "decorate" your space as you'd like; i.e. tablecloths, signage, racks, etc.. We DO NOT provide table cloths.**

If you need electricity, please write/state that in the "special requests" section on the registration page. Generators will be provided and space is limited. Electricity provided on a first come /first served basis.. You **MUST** bring your own "heavy duty" extension cord. Your cord must be at least 50' – 100' in length **ALSO** bring a power strip.

Check-in/Registration (on the day of arrival)

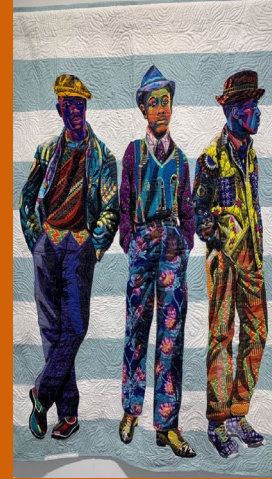
A registration and information check point will be located on the premises once you arrive. Upon arrival, **Check in to receive your vendor badges and space/location.**
